BRITISH ISLES

John Bowden (6729) HMP Perth, 3 Edinburgh Rd, Perth PH2 8AT, Scotland
Long-term prison resister who has been in jail all his adult life since 1982, after being convicted of murder. Politicised by his prison experiences, he has survived long periods of isolation, brutal beatings, and treatment amounting to torture. He is one of the UK's most articulate & vociferous prison writers, and a powerful advocate of prisoners rights.
Update: John was 'ghosted' to Perth in spring 2010. Currently fighting for a parole hearing, and a fair one too!

Ben Gunn (A8761AN) HMP Shepton Mallet, Cornhill, Shepton Mallet, Somerset BA4 5LU
Lifer who has served 30 years on a 10 year tariff, largely for standing up for his rights & resisting. Was on the roof of Horfield prison during the April 1990 prison riots. Jailhouse lawyer now fighting the state to establish an Association of Prisoners (prisoners union), and also fighting for parole. See <http://prisonerben.blogspot.com/>

BULGARIA

Jock Palfreeman - Sofia Central Prison, 21 General Stoletov Boulevard, Sofia 1309, BUL
Jock is an Australian anti-fascist with links to Bristol. In December 2009 he got 20 years for the murder and attempted murder of 2 Bulgarian racist football thugs. Jock states he acted in self-defence against a 15 strong group. He had spent 2 years on remand before sentencing. When writing dont stick anarchy symbols etc all over your letter, as he may not get it. He appreciates political books if you can send something.

The Tarnac 9

Following their arrest on 11 Nov 2008 by French Anti-Terrorism Police, mostly in Tarnac, 9 were accused of "criminal association for the purposes of terrorist activity" in connection with the sabotage of train lines. Central to the case is their alleged authorship of a book, *The Coming Insurrection*, Current details are hard to come by but it is believed all are now out on bail. **Updates would be welcomed!**

***Il Silvestre* prisoners**

Il Silvestre is an eco-anarchist organisation originally based in a social centre in Pisa, Tuscany. They publish a radical ecologist magazine called *Terra Selvaggia* (Wild Earth). They have been under attack for quite a few years now, since they received and published a communiqué written by another anarchist group called COR (*Cellule di Offensiva Rivoluzionaria*: Revolutionary Offensive Cells) in 2006. Since then many of the people involved have been arrested, mainly for terrorism and subversive association charges.

Leonardo Landi, Casa di Reclusione, Via Casale 50/a, 15040 San Michele (AL), Italy. Leonardo was arrested in November 2009. He had been on the run since May 2008. The police had issued an international warrant for robbery and subversive association against him and others. He's been found guilty of robbery and sentenced to 6 years in July 2010, however he's been acquitted of the charge of subversive association.

Alessandro Settepani, Casa di Reclusione, Via Casale 50/a, 15040 San Michele (AL), Italy. Arrested in early July 2009 after a night of police raids all over Italy (about 40) under article 270 bis of the Italian criminal code (related to "subversive association"). Alessandro and others were accused of attempted sabotage of the railway line Orte-Ancona, car theft and subversive association.

William Frediani, Casa di Reclusione, Strada Casale 50/A, 15040 San Michele (AL), Italy. Arrested in 2004. Accused of being a member of the COR (Revolutionary Offensive Cells, see above). During that year the COR claimed a series of arson attacks against local members of the right-wing party Alleanza Nazionale in Pisa, Tuscany.

Silvia Guerini & Costantino Ragusa (also see Luca Bernasconi under "Switzerland").
Silvia: Regionalgefängnis Biel, Spitalstrasse 20, 2502 Biel/Bienne, Switzerland
Costantino: moved to Regionalgefängnis Thun, Allmend str 34, 3600 Thun, Switzerland
On the 15th of April the 3 were arrested at a check point near Zurich and charged with transport of and attempt to use explosive material. The police found explosive material, a detonator and a communique about the IBM nanotech research labs in their car. Costa, Silvia and Billy are eco-anarchists linked to the Italian group *Il Silvestre* and to the Swiss eco-anarchist prisoner Marco Camenisch. All mail is translated by the state into German and censored, so don't send anything overtly political or they may not get it.

Antifa activist arrested in Naples on 1st May 2010, after a fight between activists and fascist at the yearly International Workers' Day demo. Carmelo Musumeci, Casa Circondariale, Via Maiano 10, 06049 Spoleto (PG), Italy . Anarchist lifer who has already spent more than 20 years in Spoleto's jail. Carmelo has done numerous hunger strikes, is a prolific writer and an active campaigner for the abolishment of life detention (check out the organisation he's involved with at http://www.informacarcere.it/campagna_ergastolo.php?language=uk) .

Like many others, Mauro is accused of subversive association and "being part of an anarcho-insurrectionalist group". Mauro's been getting a lot of shit for his contacts and friendships with people and groups on the outside.

The Reykjavik 9 - charged with various offences related to protests at the Icelandic parliament on 8/12/2008 in the midst of Iceland's economic meltdown. Aleksey Bychin - FBU OIK-2 IK-7 otryad No. 12, ul. Karnallitovaya d. 98, g. Solikamsk Permskiy Kray, 618545 Russia

Antifascist sentenced in May 2009 to 5 years for fighting with neo-nazis.

Aleksei Olesinov was arrested 6th of November, and accused of "hooliganism", according to statute 213, second part of Russian criminal codex. Aleksey is currently awaiting transfer.

Alexei Sokolov - 662500, city Sosnovoborsk Str. Factory 5, POBox № 214, DEC-40, LIU-37, 2 unit, Alexei Sokolov Veniaminovich (d.o.b 1973)

Human rights activist fitted up and sentenced to 3 years, currently in hospital facility after being beaten up. Working on getting parole. Letters by registered post are best. Info <http://avtonom.org/en/node/13919>

Marco Camenisch, Penitencier de Bochuz, Case Postale 150, 1350 Orbe, Switzerland
Marco is a Swiss anarchist and environmental activist who has been in prison since 1989. He is currently serving a 18 year sentence: 10 years for using explosives to destroy electricity pylons leading from nuclear power stations and 8 years for the murder of a Swiss Border Guard whilst on the run. In 2002 Marco completed a 12-year sentence in Italy for destroying electricity pylons in Italy as part of a sabotage campaign against the nuclear industry. NORTH AMERICA

AMERICANS DETAINED IN IRAN

On July 31, 2009, **Sarah Shourd, Shane Bauer, and Josh Fattal** were arrested at the border of Iran. After nearly a year, they are still being held without charges, without a single visit from their lawyer, under allegations of espionage. The families still have no idea when they might be released. The 3 are anti-war, pro-justice activists with a history of international solidarity.

Angola 3

Albert Woodfox's conviction was overturned in July 2008, but they still won't let him out... Albert Woodfox, Herman Wallace and Robert "King" Wilkerson, are still known by their campaign name The Angola 3 (King was released at the beginning of 2001). They initially arrived at Angola with sentences for unrelated robberies. Their subsequent activism made them targets of the all-white prison administration and all 3 were subsequently fitted up in prison for murders and got life sentences. Herman & Albert are continuing their struggle to prove their innocence. Both have petitions pending before various courts and a lawsuit having spent most of their 40 years in solitary confinement. Veronza Bowers Jr, #35316-136, P.O. Box 150160, Atlanta, GA, 30315, USA. Veronza was convicted of murder of U.S. Park Ranger on evidence of 2 government informers, both of whom received reduced sentences for other crimes by the Federal prosecutor's office. No eye-witnesses & no evidence independent of informants to link him to the crime.

Romaine Chip Fitzgerald, #B27527, A-1-111, P.O. Box 5101, Delano, California 93216, Kern Valley State Prison, USA. In September 1969, Chip was wounded and arrested in connection with a police shoot-out. He was tried for assault on police and other, related charges, including the murder of a security guard. He was convicted and sentenced to death. He was 19 years old.
